

Certification of Candidate

Notice is hereby given that a General Election will be held at the regular polling places in each precinct of said County of Daviess, and that the polls will be open between the hours of six (6:00) o'clock in the morning until seven (7:00) o'clock in the evening, on the first Tuesday after the first Monday in November, 2022 being the 8th day of November, 2022, for the purpose of nominating candidates for state, district, and county offices to be voted for at the General Election to be held on Tuesday, the 8th day of November, 2022 and electing Township Committeemen and Committeewomen. That the hereinafter mentioned list contains the name and address of each candidate for nomination, together with a designation of the office for which he/she is a candidate, and the party or principle that he/she represents; the hours during which the polls will be open, and the regular polling locations. The following are candidates who have filed in the office of John R. 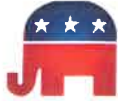
